### JNA's challenge to strengthen UHC in Japan and enhance nursing capacity in community: from the perspective of public health nurses, midwives, and nurses

#### About Japanese Nursing Association:



JNA is the largest healthcare professional organization in Japan, which advocates nurses (public health nurses, midwives, nurses, and assistant nurses). Its membership is on voluntary basis. JNA is a nationwide organization that operates in collaboration with 47 prefecture nursing associations (corporate members). Established in 1946, JNA was certified as a Public Interest Incorporated Association in 2011.



#### Symposium abstract:

In comparison to other countries, Japan is recognized as having achieved UHC at an early stage. To sustain UHC, given that Japan's population is ageing at the fastest pace in the world and the birth rate continues to decline, the question is how to effectively, efficiently, and comprehensively support the lives of diverse populations in communities.

In Japan, the "Community-based Integrated Care System" has been established and promoted to support home care for the elderly. Further measures have been initiated to develop a social security system for all-generations (UHC) that includes not only the elderly, but also children, the disabled, the needy, and even all healthy people with potential needs. In advancing this, the key to the realization of UHC is to secure the workforce and establish an efficient mechanism to support the new system, as the working population is rapidly shrinking due to the declining birth rate.

Nursing has the potential to contribute to these two resolutions. Nursing professionals are always on the front line in protecting the health and well-being of the population, therefore, they should demonstrate their power and leadership in both practice and policy toward the realization of robust UHC.

In Japan, there are three nursing professions: public health nurses, midwives, and nurses. This symposium will share how each of the three professions have worked together to address the challenges of UHC and how they are currently working to improve UHC. It also aims to advance the discussion of the potential contribution of nursing to the realization of UHC.

The booklet provides the institutional framework of nursing, its historical development, and current challenges in Japan.

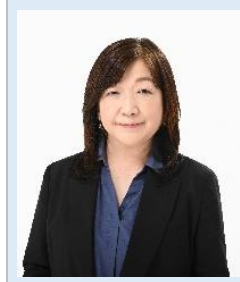


#### “Midwifery in Japan Overview (English version)”

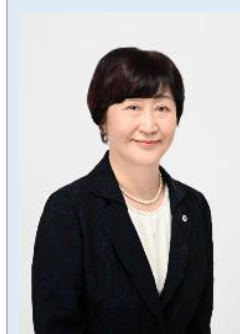


### **Dr. Yukari Nakano**

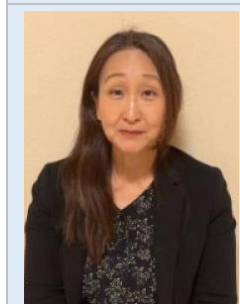
## Speakers:
